Documenting an Exam

DATA BASE SAMPLE: PHYSICAL EXAMINATION WITH ALL NORMAL FINDINGS GENERAL APPEARANCE: (include general mental status) ... (Document if you need to use a large cuff or thigh cuff for an obese arm.) ... findings regarding CVA tenderness under abdomen – see example * LUNGS

DATA BASE SAMPLE: PHYSICAL EXAMINATION WITH ALL NORMAL

HISTORY OF PRESENT ILLNESS. (. chronology. and progression, pertinent positive and negatives) Patient, an 82 year old Caucasian male, was in his usual state of health until 2 weeks ago, when he experienced sudden onset slurred speech, dizziness, weakness in his right leg which precipitated a fall in his home.

Example of a Complete History and Physical Write-up

Medical record documentation is required to record pertinent facts, findings, and observations about an individual's health history including past and present illnesses, examinations, tests, treatments, and outcomes. The medical record chronologically documents the care of the patient and is an important element contributing to high quality care.

PHYSICAL EXAMINATION. A. complete physical examination is included as part of every Bright Futures visit. The examination must be comprehensive and also focus on specific assessments that are appropriate for the child's or adolescent's age, developmental phase, and needs. This portion of the visit builds on the history gathered earlier.
